



## 34TH ANNUAL JURIED EXHIBIT

Once again the National Collage Society, Inc. is hosting an online juried exhibit. There are many benefits to having an online exhibit. There are no shipping fees, no traveling and global access to the exhibit. Collages will still be for sale and as an additional bonus there will be no sales commission. This exhibit will still count toward your NCS Signature Membership.

Entry Deadline: Friday, August 4, 2018

Exhibit Dates: November 1, 2018 to October 1, 2019

### **ELIGIBILITY**

- This exhibition is open to all artists
- Work produced in a classroom or under instruction is not eligible.
- All works must be ORIGINAL, two or three dimensional, mixed-media glued collage. All work must be well photographed. Work not suitably photographed will be declined by the jury.
- Collages that have been in any previous NCS juried shows are not eligible.

### **JURY OF SELECTION**

A jury of selection will review all entries and may choose one or two per eligible artist. Notification of the jury's decisions will be made in early September. All results will be sent via e-mail. Please make sure to provide a valid email address to receive your jury results. Mailed entries (CDs and slides) will not be returned.

### **AWARDS**

There will be two types of awards—cash and materials. Award winners will be chosen by the Awards Judge after the show is opened in November. All collages receiving awards will be posted as such on the website.

## **ENTRY**

Each artist may enter one or two digital entries, **Friday, AUGUST 24, 2018**

**Digital entries** should be jpegs at least 5" x 5" at 300 ppi. Digital entries should have a filename that includes the artists last name as well as the entry number (#1 or #2). Digital entries can be submitted online via the NCS website using EntryThingy, sent on a CD or e-mailed to [ncscollage@gmail.com](mailto:ncscollage@gmail.com). **Please note that EntryThingy is the preferred method for entry.** If sending a CD, please send all entries on one disk.

## **FEES**

The entry fee for the 2018 Juried exhibit is \$50.00. If you are already a member and have paid your yearly membership fee then the entry fee is \$15.00. This entry fee entitles you to enter up to two pieces of work.
